INFECTION PREVENTION AND CONTROL

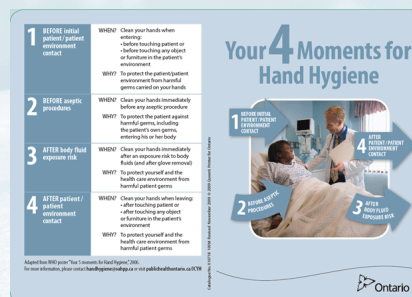
IT IS THE TIME OF YEAR WHERE WE ARE NOTICING A HIGH RATE OF RESPIRATORY INFECTIONS AND OUTBREAKS IN THE SURROUNDING AREAS. WE ENCOURAGE ALL RESIDENTS TO PLEASE UTILIZE THE ALCOHOL-BASED HAND SANITIZER DISPENSERS AROUND THE HOME TO PERFORM HAND HYGIENE.

WHEN VISITING RESIDENTS, PLEASE ABIDE BY THE FOLLOWING GUIDELINES:

1. IT IS THE VISITOR'S RESPONSIBILITY TO COMPLY WITH HOME'S POLICIES, INCLUDING THOSE THAT PROTECT THE HEALTH AND SAFETY OF RESIDENTS, STAFF AND OTHER VISITORS.
2. FOLLOW ALL INFECTION PREVENTION AND CONTROL PRACTICES SUCH AS HAND HYGIENE, RESPIRATORY ETIQUETTE, PERSONAL PROTECTIVE EQUIPMENT (PPE) REQUIREMENTS (GOWNS, GLOVES, MASKS, ETC), ISOLATION AND/OR PHYSICAL DISTANCING DIRECTIVES WHEN INDICATED.

PLEASE NOTE THAT IF YOU ARE VISITING THE HOME AND OBSERVE SIGNAGES POSTED AT THE OUTSIDE OF THE RESIDENTS ROOM, PLEASE SEE A NURSE BEFORE ENTERING AS YOU MUST WEAR THE APPROPRIATE PPE (PERSONAL PROTECTIVE EQUIPMENT). THIS IS TO ENSURE WE REDUCE THE RISK OF TRANSMISSION IN THE HOME AND TO PROTECT THE HEALTH AND SAFETY OF VISITORS.

1. READ THE VISITOR POLICY AND ASK STAFF FOR CLARIFICATION IF YOU HAVE QUESTIONS.
2. SCREENING – VISITORS MUST FOLLOW ALL ILLNESS SCREENING PROCEDURES IN PLACE IN THE HOME AT ALL TIMES. WHEN YOU ARE EXPERIENCING ANY SYMPTOM OF ILLNESS, PLEASE DO NOT VISIT THE HOME.
3. SIGNING IN – ALL VISITORS MUST SIGN IN WHEN VISITING A RESIDENT AND ABIDE BY ANY ADDITIONAL MONITORING REQUIREMENTS THAT MAY BE MANDATED BY PUBLIC HEALTH OR ANY OTHER REGULATORY AUTHORITY.



Resident Rights

9. Every resident has the right to meet privately with their spouse or another person in a room that assures privacy.

10. Every resident has the right to pursue social, cultural, religious spiritual and other interest, to develop their potential and to be given reasonable assistance by the licensee to pursue these interests and to develop their potential
